




Association of Structural Pest Control Regulatory Officials (ASPCRO)

In August, our 2015 ASPCRO Conference in Fort Lauderdale, Fla., was a resounding success. With a higher-than-average attendance of 175 individuals comprised of state agency representatives, regulators, educators and researchers, we installed officers (see "Roll Call," opposite page), presented several symposia, and awarded honors to the following:

• Resolution of Appreciation for Rollins and the staff of the Rollins Learning Center (RLC), accepted by Wayne Golden, assistant vice president, government relations, Rollins Inc. Rollins Inc. hosted the ASPCRO/National Pest Management Association (NPMA) Structural Fumigation Workshop for U.S. Environmental Protection Agency (EPA) Pesticide Registration and Risk Evaluation Scientists in March 2015 at the RLC in Atlanta. The Rollins participants' high level of commitment contributed to the success of the workshop, which was filled with demonstrations and technical information. Participants found the workshop to be an invaluable source of information on the professional care, planning and performance of structural fumigation services. It was resolved that ASPCRO recognizes and sincerely appreciates Rollins Inc., the RLC staff, and subject matter experts from Western Pest Services, Orkin and The Industrial Fumigant Co. for their outstanding efforts and dedication in hosting and conducting the workshop.

• 2015 ASPCRO Presidential Award of Excellence. presented to Chris Gorecki, vice president, government relations and environmental stewardship, Rollins Inc. Gorecki was recognized for his tireless dedication



and willingness to work with ASPCRO to advance the knowledge and understanding of issues that affect the regulated community to ensure sound and fair regulatory approaches that continue to protect human health and the environment. He is respected for both his high standards of excellence and his willingness to always go above and beyond the call of duty.

• 2015 ASPCRO Hall of Fame inductee Mike Page, retired from the Florida Department of Agriculture and Consumer Services (FDACS). Page began his FDACS career in November 1986 as a chemist in its Chemical Residue Laboratory, where he worked 10 years before being appointed lab director of the Pesticide Laboratory. In this role, Page was responsible for pesticide analyses in product formulations, environmental and forensic samples. In April 2004, Page was appointed chief of the Bureau of Entomology and Pest Control, with statewide responsibility for regulating structural pest control and mosquito control. Most recently, Page was assigned to head the division's Special Projects Office, where he

focused on a variety of issues related to integrated pest management (IPM), exotic invasive termites, building bed bug awareness and mosquito control in Florida. Page joined the ASPCRO board of directors in 2011 and served as both an at-large member and secretary to the board. He also served as chair of ASPCRO's Pest Management in Schools Committee.

In his role as chair, Page was instrumental in forwarding the implementation of IPM programs in schools. Under his direction, the committee, having received a request from the EPA's Biopesticides and Pollution Prevention Division (BPPD), developed a Model Contract for Schools seeking IPM services from a pest management professional (PMP). Page served on BPPD's subcommittee on School IPM and, after identifying the need for training for the EPA's Center of Expertise for School IPM Staff, led ASPCRO's development and implementation of the training.

In addition, Page served as a member of the EPA's Pesticide Program Dialogue Committee's IPM Workgroup. Working closely with the EPA on this initiative, Page helped ensure the state's perspective on IPM in Schools would be considered. This included the development of a survey of states to determine the status of IPM programs in schools nationwide.

With his broad background in pesticides, Page lent his expertise to a number of other committees, as well serving as a member of the Inspector Training and Green Building Standards committees. He also actively participated and represented ASPCRO in numerous trainings and other activities - for example, as a presenter and facilitator for the EPA's Pesticide Inspector Residential Training focusing on structural pest control.

Another resolution was passed in recognition of Purdue University Project Manager/Systems Analyst Vicki Cassens for her work on ASPCRO's website and social media pages.

Last but not least, ASPCRO formally recognized the great job FDACS representatives did in hosting and helping to organize this year's meeting. The event really showcased the state,

right down to the exploding population of the invasive conehead termite (Nasutitermes corniger).

In short, we had a great agenda and speakers. There were lots of positive comments and feedback, particularly as it pertains to the risk/benefits analysis of pesticide use. Of particular note was our discussion on rodent risk mitigation. It's been seven years since this was a top issue, and the long view is that the industry has been able to standardize rodenticide safety measures to the point where's it's practically a non-issue today. We believe the industry should be applauded for its efforts in that regard.

Entomological Society of America (ESA)

Our annual elections have just concluded, and Dr. Zia Siddigi, director of quality systems for Rollins in Atlanta, has become our directorelect, taking the reins for 2017. Previously, Zia was on the development team, and then the committee chair. for our Associate Certified Entomologist-International (ACE-I) program. While most of the 2016 ESA Certification Board is comprised of incumbents, Rollins' Pat Copps is rolling off the board

and Dr. Laura Higgins, director of research at DuPont Pioneer, is taking Copps' seat. In addition, Forrest St. Aubin, BCE-Emeritus, will be named past director of our Certification Board next year.

This has been a busy year for our organization, and I'm happy to announce we have a new certification administrator, Matthew Chism. He started with ESA in February, and has been a tremendous help with his background in both photography and information technology (IT).

Another new development that we're thrilled about is, after two years of writing and editing, the Associate Certified Entomologist (ACE) Study Guide is now ready and for sale (Editor's Note: Please see p. 13 of this issue for more information). Not only does IPM for the Urban Professional help prepare those studying for the ACE test, but it's a good all-around reference guide for integrated pest management (IPM). It's our hope that pest management firms incorporate the guide into their employee training programs.

Research, education continue

On the regulatory front, we have recently written a policy statement on pollinator health that supports the White House's National Strategy to Promote the Health of Honey Bees. We wrote another statement that underscores the importance of managing and mitigating tick-borne diseases with an integrated pest management (IPM) approach.

At press time, we have a number of other statements under development, with topics as diverse as invasive species and insecticide resistance. A five-member policy capability committee leads ESA's science advocacy efforts. The committee also names five Science Policy Fellows annually to represent the Society in Washington, D.C. These scientists serve two-year appointments and meet with legislative staffs and federal agency leaders. ESA is also looking for ways to unite the international scientific community around grand

challenges that affect the science of entomology, both here in the United States and around the world. Examples

include seeking ways that entomology can help contribute to increased food production, lowered risk of disease transmission, and improved living conditions for all.

International program grows

Last October, at the National Pest Management Association's (NPMA's) PestWorld convention and expo in Orlando, Fla., we introduced the ACE-I program. Since then, we received a number of applications, and four people have already earned certification. This strong kickoff to the program has encouraged us to do even more outreach and travel to spread the word worldwide. That means in 2016, ESA delegates will be attending Pest Management Canada 2016 in Halifax, Nova Scotia, in April and the 2016 Federation of Asian & Oceania Pest Managers Associations (FAOPMA) Conference on Australia's Gold Coast in Australia in September, among other international shows.

At this year's NPMA PestWorld convention and expo in Nashville, we will present the ACE Professional Award to Mike Goldman, ACE, of Purity Pest Control. Based in Ontario, Mike became an ACE back in 2010, before we started the international arm of the program. To accomplish this feat, he became licensed across the border in Michigan, took the test and passed. This took a lot of initiative on his part.

Upcoming events

In November, we will host our 63rd Annual Meeting, Entomology 2015. We have several great urban pest symposia planned, including a discussion on state-ofthe-art monitors for arthropods and other pests. We'll also present a session on the benefits of entomology careers in pest management.

This will be a particularly interesting meeting because we are co-hosting the event at the Minneapolis Convention Center with the Agronomy, Crop, and Soil Science Societies, which are headquartered in Minneapolis. Although there will be a focus on crop entomology, we will still have plenty of different urban symposia going on. Not only will we

host our traditional board-certified entomologist (BCE) symposium, but Rollins is sponsoring an Urban Entomology reception.

Last but not least, we're just 11 months away from the 2016 XXV International Congress of Entomology (ICE) 2016, taking







place Sept. 25-30, 2016, in Orlando, Fla. It's going to be,

by far, the biggest meeting of entomologists ever. There will be lots of cool tours and activities for urban entomologists. I'm also in charge of running the Entomological

Foundation, which focuses on serving the training needs of

K-12 educators to try and help them get kids interested in insects. We're really excited to host the Insect Expo at ICE on Sept. 28. We expect nearly 4,000 students to visit and learn more about the fascinating world of insects.

This will truly be a once-in-a-generation opportunity. No matter what type of entomology one studies, there's going to be something for everyone at ICE.



When it comes to the work of the PPMA, whose mission is to protect, defend and grow the professional pest management industry through a comprehensive integrated consumer outreach program, the job is never done. It has spent all year implementing various components of its multi-faceted marketing plan, and is now building a new plan with strategies and tactics that reflect cuttingedge techniques to reach the consumer in 2016.

Here are just a few of the

ways PPMA has served as the voice of our industry by reaching out to consumers over the past few months:

- Summer pests mean lots of media interest PPMA's media relations program continues to bring positive exposure to the industry as a whole, with more than 900 placements and 650 million impressions at the end of August. Some notable placements include the "Bugs Without Borders" survey results in *USA Today*, "This Old House" and on NPR.org and MSN.com; information about mosquito bites on CNN.com, Yahoo! Health, The Weather Channel and Prevention.com; the importance of insect repellents in *Family Circle*; and the effects of the California drought on spiders in LiveScience.com, which was also picked up by Yahoo! News, BusinessInsider.com and MSN.com. We also received syndicated pick-up from a story with Tribune Media Services featuring information on ticks.
- Bed bug ads take off in airports In June, PPMA kicked off its first-ever airport advertising campaign in nine major hubs across the country, including Atlanta, Chicago (O'Hare), San Jose, Dallas-Fort Worth and Philadelphia. The ads, which were visible in concourses, gates and baggage claim areas where they couldn't be missed, garnered more than 115 million impressions.
- NPMA's Bug Barometer predicts pest populations The National Pest Management Association (NPMA)-branded Bug Barometer is a semiannual forecast indicating what Americans can expect from pest populations by region and by season. The first Bug Barometer was issued in April to great media response from outlets including Popular Science, USA Today, Angie's List and The Weather Channel. The fall/winter forecast was released in

early September prior to the official change in seasons.

• Commercial audience focus — PPMA continues its education efforts to various commercial industries for which pest control is crucial through articles in trade magazines and websites. PPMA also recently added a new



commercial section to its consumer website, PestWorld.org. The section discusses pest problems by commercial industry, features a library of bylined articles that appeared in various publications, and focuses on the importance of outsourcing pest control to professionals.

- Updated members-only site In June, PPMA rolled out an updated PPMATools.org, its exclusive online marketing hub. The site features new content, expanded search capabilities, easier navigation and much more.
- Pollinator gardens project On Aug. 22, National Honey Bee Day, PPMA collaborated with NPMA to organize a community program that showed the industry's commitment to protecting pollinator health. Member companies across the country marked the first National Day of Service; they were encouraged to plant pollinator gardens on their properties or in their communities to foster foraging sites. RISE (Responsible Industry for a Sound Environment)

In this, our 25th year, we've been looking back and forward at our evolution as an association —from defense to offense, and how we have remained true to our mission to represent the interests of the specialty pesticide and fertilizer industries. For the months and year ahead, there are four areas of particular interest to pest management professionals (PMPs):

Clean Water Act

The final Clean Water Rule went into effect Aug. 28, 2015, with 13 states and individual stakeholders filing legal challenges to stop implementation. Those cases have been consolidated in the Sixth Circuit. However, last month a North Dakota judge granted an injunction responding to the 13 states — specifically, Alaska, Arizona, Arkansas, Colorado, Idaho, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, South Dakota and Wyoming. Applicators in the remaining 37 states must comply with the rule, which greatly expands Clean Water Act (CWA) permitting requirements under the National Pollutant Discharge Elimination System (NPDES) program for pesticide applications.

The remedy for this regulatory grab by the U.S. Environmental Protection Agency (EPA) and the U.S. Army Corps of Engineers continues to be through federal legislation and oversight. On Aug. 27, we joined our Waters Advocacy Coalition partners for a "district phone day," urging people to call their senators' district offices to create a local conversation about the negative impacts of the rule and generate support for S. 1140, which would require EPA and the Corps to redraft the rule.

Also, in September RISE created two new opportunities on Capitol Hill to work on federal legislative language to fix much of what is wrong in the rule. My work with our federal legislative team continues to be focused on how the many pesticide and fertilizer uses we represent can bring real examples of negative impacts to public health, safety and infrastructure to drive legislation.

Pollinators

Since publication this summer by the White House of its

strategy for pollinators, in which RISE was named a national stakeholder in the creation of pollinator habitat and forage, activism has made a strategic shift to focus on specialty pesticides and their use in lawns, landscapes, rights-of-way and mosquito control.



Under our Bee Friendly (#beefriendly) campaign, we continue to provide resources and to be the voice of our industry in what is now a state and local conversation. We have been actively opposing city and county efforts to pass "bee-friendly resolutions" that are simply a precursor to pesticide ban laws and campaigns to roll back state pesticide pre-emption. We are watching a number of states where neonicotinoid ban bills failed to pass during the 2015 legislative session, so are now being advanced locally in counties or are being retooled for re-introduction in 2016 state legislative sessions.

Pre-emption

On Oct. 6, we will have completed work in Montgomery County, Md., when Bill 52-14 — the proposed ban on pesticides used on private and county property for lawns, turf, ornamentals, trees and herbaceous plants — will have been voted on by the full county council. Our two-year strategy to kill this bill represents our largest coalition-building effort in RISE's 25-year history. Working closely with 400 people, including green industry and pest management professionals and residents, we generated 1,800 opposition letters; four hundred of these were original and hand-signed. These letters formed the foundation of our integrated strategy to prevent a ban on product use on private property.

Media campaign

This summer and fall, we have been partnering with U.S. Women's Soccer team Co-captain Abby Wambach to tell the turf story. Attacks on turf and lawn care continue to be the entry point for anti-pesticide activism targeting our industry—and the first step in attacks on pesticide pre-emption.

At press time, Wambach's passion for real, well-maintained turf has created more than 19 million media impressions for us (and counting!). It has drawn an unprecedented number of people wanting to learn more to DeBugTheMyths.com, through her Facebook posts and tweets.
